## **Section B: Oral Task Requirements**

### **Second Additional Language:**

During the year, learners offering a Second Additional Language must complete, as a minimum, the following oral tasks:

- Task 1: Reading and discussion of a previously prepared document
- Task 2: Role Play/Situation
- Task 3: Listening Comprehension
- Task 4: Conversation

### **First Additional Language:**

Learners offering a First Additional Language should do the following during the year:

- listening comprehension (Task 1)
- prepared speech (Task 5)
- other (Task 6), e.g. prepared reading aloud/ unprepared speech/ informal speaking in group work

### **Home Language:**

Learners offering a Home Language should do the following during the year:

- listening for comprehension (Task 1)
- unprepared speech (Task 4)
- either two prepared speeches OR one prepared speech and one unprepared reading aloud (Task 7 and Task 8)
